### **Summary**

Differentia specifica of the course are interconnected with accent on the analysis of economic (1) system in (2) their transformation. Consequently, main goal of the course is to develop knowledge and analytical potential of the students in specific theoretical spaces, covering problems of economic transformations, both internal and external, in the interconnection with transformations of technologies, institutions, social and cultural life. Geoeconomic and geopolitical aspects are also included in the analysis. Among key questions of transformations authors will teach theory of genesis of knowledge-based economy and consequent transformations of market, money, capital and property relations. Another important chapter of the course - counter-points of transformation during last 100 years of Russian (pre-soviet, soviet, post-soviet) economic system.

### **Program**

#### Topic 1.

### Economic systems and their development

Economic systems: neoclassic, classic, institutional and neoinstitutional approaches. Types of economic systems: methodology of formation and civilization approaches, methodology of comparative economics. Structure of economic systems. Historical character of economic systems. Development and performance. Pre-industrial, industrial and post-industrial systems. Traditional, market and post-market economies. Pre-capitalist, capitalist and post-capitalist economic systems.

### Topic 2.

### **Economic transformations.**

Transformations of economic systems: neoclassic, classic, institutional and neoinstitutional approaches. Inter-system transformations: genesis and 'sunset' of economic systems. Inter-system transformations. 'Mega'-transformations: 'stable' and transformation economies: methodology and theory of analysis, differentia specifica. Space and time of economic transformations; specific features.

Non-linear transformations. Progress and regress, e- and in-volution, Progressive and regressive economic transformation. Objective laws and historical variations of economic transformation.

Types of transformations. Political economy of revolutions and reforms. technological, economic, social, political and cultural transformations; their interconnection.

### Topic 3.

# Non-linear transformation from industrial towards post-industrial economy and reindustrialization: changes in the structure, type and resources of development (chapter I)

Variations of the 'names' of transformation: service, post-industrial, information, knowledge-based, neo-, digital etc. economies. Problem of transformation towards 'post-economic formation' and 'realm of freedom' (Marx).

Main socio-economic changes, produced by post-industrial transformation:

New structure of economy; problem of 'service' economy and 'fictitious' sector; new role of education, science, culture and nature; labor, free and leisure time; place and role of industry and agriculture in post-industrial economy; Reindustrialization and new quality of material production. New actors: e-cottage, creative corporation, net-work enterprise. Information and knowledge as main recourses of development. Information and knowledge as common and private goods. New type of interconnection between society and nature; nature as cultural value and economic recourse. Political economy of sustainable development: theoretical foundations.

### Topic 4.

# Non-linear transformation from industrial towards post-industrial economy and reindustrialization: market and money, capital and labor (chapter II)

Transformations of market relations: 'market fundamentalism' or total 'marketisation' of human life. Political economy of the sign and market of simulacra. Virtual money and sector of fictitious values. World economic and financial crisis in the context of post-industrial transformations.

Global hegemony of capital and its technological basis. Financialisation and its technological basis. New economic role of knowledge, creativity and personality: intellectual, human, social and so on 'capitals'. Intellectual property, intellectual rent and their future.

Work, labor and creativity; 'homo economicus' and homo creator: transformations of values and motivations; post-economic values and motivation. New types and forms of employment: part-time job, job-sharing, and so on. Creative activity and problem of its exploitation.

### Topic 5.

## Non-linear transformation from industrial towards post-industrial economy and reindustrialization: contradictions and future (chapter III)

If post-industrial transformations reality as global ones: debates. Geo-economics of industrial and postindustrial systems. North – South: contradiction of 'post-industrial' capital and industrial labor? Potential and limits of catching-up development: lessons from development economics of XX century. 'Leap-frog strategy': dream or reality?

Post-industrial world and crisis of modern economic model: revival of neo-liberalism, qualitative renovation of 'social state' or post-market and post-capitalist economy?

New economic phenomenon: 'wikinomics', 'open source', 'free soft-ware', 'copy-left' and 'old' ideas of economy of solidarity. Creative activity and problem '80-20': new economy of 'realm of freedom.

### Topic 6.

### Transformation in post-soviet economies

Soviet-type economy: nature, genesis and fall (neoliberal and different Marxists interpretations. Theoretical and methodological qualification of Russian transformations in XX century. Post-soviet transformations: discussions on the nature, models and strategic goals of 'reforms'.

What kind of economy do we have in modern Russia: differentia specifica of market and regulation, capital and labor, performance and development.

Social and political prerequisites and consequences of economic 'reforms' in post-soviet economy. National invariants and global context of Russian transformations.

Discussions about future model of Russian economy: public and private sectors, role of the state and civil society in regulation of economy, social justice and market efficiency in specific Russian co0ntext. Russian economy: oil-oriented stagnation, neo-industrialization or leap-frog strategy of transformation towards knowledge-based economy?
